A discussion was held on possible ways this could be done and if the Cemetery Office should move to the Town Hall, along with the records. Further discussion with both the Commission and Finance Director is needed to make this happen.

- 2. A motion and 2nd to Table the reorganization of the Board until all members could be present. Vote--Unanimous
- 3. R. Polizzoti reported that he had picked up the broken hot top in the Cemetery streets. They will need some work to keep them passable. He repaired 6 more water leaks. He also got some bungee cords and strapped the trash barrels down to keep them from blowing all over the Cemetery.
- 4. The Finance Director will post the part-time job.
- 5. M. Kastrinelis reported that Elm trees are not on the tree list from the architects design for the front entrance. The Commission felt that disease

 - 9. The money to engineer the new section of the Cemetery was passed at the Annual Town Meeting. The process will start as soon as the CPA work is finished.

 - 11. R. Guptil spoke about the Spanish-American War markers that are needed. They are now made of aluminum and cost \$23.95 each. We need 4 of them, which will cost \$95.80 plus shipping \$14.70 would be \$110.50. A motion by M. Kastrinelis and 2nd by R. Dower to purchase the markers not to exceed \$150.00, Vote—Unanimous.
