18 KING ST/4 GARRISON ST: Lot Line Adjustment

Schindler: We must deny this ANR application. These are two grandfathered preexisting nonconforming lots, because of that, allowing this ANR would cause the lots to lose their preexisting legal status, and render them non-buildable. In speaking with the Zoning Enforcement Officer, we have advised the applicant to file for a special permit with the Zoning Board of Appeals to allow for the existing nonconformities to become legal, as no new nonconformities are being created, and the existing ones are not being made worse.

MOTION: Sorenson made a motion to deny the ANR for 18 King St/4 Garrison St. McNulty seconded the motion. The vote was 4-0, unanimous in favor.

TOWN PLANNER UPDATE
