WORKPLACE SAFETY and REOPENING STANDARDS FOR RECREATIONAL BOATING BUSINESSES – Phase II

June 9, 2020

INTRODUCTION

On May 18, 2020, Governor Baker issued [COVID-19 Order No. 33](#), implementing a phased reopening of workplaces and imposing workplace safety measures to address COVID-19. That same day, he issued [COVID-19 Order No. 34](#), which directed the Secretary of the Executive Office of Energy and Environmental Affairs (EEA) “to issue guidance for the implementation of the generally applicable COVID-19 workplace standards by operators of and participants in outdoor recreational activities.”

In Phase I, recreational boating facilities, were permitted to operate solely for the purpose of enabling recreational boating, including rowing and sailing facilities, yacht clubs, boat clubs and boat rentals; provided, however, that the occupants of a vessel be limited to a single household group and that no more than ten people are aboard a single vessel at any one time.

On June 6, 2020, Governor Baker issued [COVID-19 Order No. 37](#), authorizing the re-opening of Phase II enterprises. This Order reaffirmed the Secretary of EEA’s authority to issue Sector Specific Rules for outdoor recreational activities to supplement the generally applicable COVID-19 safety rules applicable to all workplaces in the Commonwealth. Pursuant to that authority, as part of Phase II of the Commonwealth’s reopening, recreational boating businesses will be permitted to modify their operations pursuant to the guidelines set forth below.

This document provides guidance for recreational boating businesses on how to implement workplace safety standards and other public health guidance (“COVID-19 measures”) in the context of their outdoor recreational operations in the Phase II of the Commonwealth’s reopening. Operators who fail to implement applicable COVID-19 measures may be sanctioned in accordance with COVID-19 Order No. 37. Operators are further reminded that in addition to implementing COVID-19 measures in Phase II, they must still comply with all federal, state and local laws.

LIMITATIONS ON OUTDOOR RECREATIONAL ACTIVITIES AND FACILITIES

In Phase II, recreational boating facilities, including rowing and sailing facilities, yacht clubs, boat clubs, and boat rentals may continue to operate; provided, however, that no more than 10 people are aboard a single vessel at any one time.

In addition to complying with the aforementioned limitations, recreational boating facilities must implement the following safety measures detailed below.

IMPLEMENTING SAFETY MEASURES FOR YOUR OPERATION

Recreational boating facilities must ensure that the following COVID-19 Measures to protect consumers and employees.

Social Distancing	<ul style="list-style-type: none">• All persons, including employees, customers, and vendors should remain at least six feet apart to the greatest extent possible, both inside and outside workplaces• Establish protocols to ensure that employees can practice adequate social distancing• Provide signage for safe social distancing• Require face coverings or masks for all employees and customers
Hygiene Protocols	<ul style="list-style-type: none">• Provide hand-washing capabilities throughout the workplace• Ensure frequent hand washing by employees and adequate supplies to do so• Provide regular sanitization of high touch areas, such as workstations, equipment, screens, doorknobs, restrooms throughout work site
Staffing and Operations	<ul style="list-style-type: none">• Provide training for employees regarding the social distancing and hygiene protocols• Employees who are displaying COVID-19-like symptoms do not report to work• Establish a plan for employees getting ill from COVID-19 at work, and a return-to-work plan
Cleaning and Disinfecting	<ul style="list-style-type: none">• Establish and maintain cleaning protocols specific to the business• When an active employee is diagnosed with COVID-19, cleaning and disinfecting must be performed• Disinfection of all common surfaces must take place at intervals appropriate to said workplace

The application of these measures to for recreational boating is detailed below.

I. Social Distancing

- ❖ No more than 10 people may be in a boat at one time and social distancing guidelines must be followed.
- ❖ Docks are to be used to facilitate boating access only. On-dock gatherings are prohibited under any circumstances.
- ❖ Common areas such as gazebos where people are likely to congregate and social distancing cannot be maintained remain closed for Phase II.



- ❖ Picnic areas should be closed if social distancing cannot be maintained.
- ❖ Organized and in person events, such as fishing derbies and tournaments or organized sailing event/regattas are not allowed.
- ❖ Fishing derbies and tournaments are allowed provided such event is remote/virtual and follows the following guidelines:
 - Fishing tournament/derby organizer(s) formulates a virtual plan for fish measuring and price allocation (includes online registration, catch entries, and awards).
 - Weigh ins conducted virtually or if in person, then outdoors and maintaining social distancing and group size limits.
 - No gatherings of more than 10 people are allowed at any time before, during or after on land or docks.
 - All participants must provide their own gear.
 - Shore anglers must adhere to all social distancing guidelines and the use of multiple water bodies to appropriately distance individuals is strongly encouraged.
- ❖ Fuel dock operators shall keep vessels spaced on the fuel dock at least 6 feet apart.
- ❖ Lunch and break times for staff shall be staggered, regulating maximum number of people in one place and ensuring at least 6 feet of physical distancing during any meeting.
- ❖ Face coverings are required for all workers in accordance with [COVID-19 Order 31: Order Requiring Face Coverings in Public Places Where Social Distancing is Not Possible.](#)
- ❖ Minimize the use of confined spaces (e.g., elevators, control rooms, on-shore vehicles) by more than one individual at a time; all employees and customers in such spaces at the same time are required to wear face coverings.
- ❖ For launch boats, the captain, staff and patrons must keep at least 6 feet apart and wear proper face coverings or PPE including disposable gloves, eye/face protection. If social distancing cannot be accomplished in a single trip, then separate trips must occur to adhere to the 6 feet social distancing requirement. If possible and practical, install Plexiglass shield between driver and passengers.
- ❖ For dinghy docks, all dinghies must wait for dinghy dock to be clear of any and all persons before approaching.
- ❖ Yacht club/boat club staff should not assist boaters with launch/retrieval or boat readiness except as necessary for ADA compliance. Staff should minimize interactions with boaters.
- ❖ Safety boats at rowing and boating facilities, boat ramps and canoe launches shall be operated by only one person, unless six-foot social distancing can be maintained by a crew of more than one.
- ❖ Sailing and rowing programs and lessons may be operated provided that organizers follow EEA's [Workplace Safety and Reopening Standards for Businesses and Other Entities Providing Outdoor Adult Sports, Supervised Adult Youth Sports Leagues, Summer Sports Camps](#) guidance.
- ❖ Remote and credit-card transactions are encouraged.



II. Hygiene Protocols

- ❖ Ensure access to handwashing facilities on site, including soap and running water, and allow sufficient break time for employees to wash hands to frequently; alcohol-based hand sanitizers with at least 60% alcohol may be used as an alternative.
- ❖ Employees should wear gloves as appropriate and when touching shared equipment.
- ❖ Paperwork should be handled electronically to the maximum extent possible.
- ❖ Employers must supply employees at workplace location with adequate cleaning products (e.g., sanitizer, disinfecting wipes) to sanitize shared equipment and touch surfaces.
- ❖ Post visible signage throughout the site to remind employees of the hygiene and safety protocols, including regular hand washing.
- ❖ Require regular and not less than daily cleaning and sanitation of all high-touch areas such as workstations, door handles, and restrooms.

III. Staffing and Operations

- ❖ Provide training to workers on up-to-date safety information and precautions including hygiene and other measures aimed at reducing disease transmission.
- ❖ Limit visitors and service providers on site; shipping and deliveries should be completed in designated areas, outside the facility if possible.
- ❖ Log all persons who are present at site, including customers, to enable contact tracing (name and phone number or name and email address). It is recommended that at least one member per household/car is logged to assist any contact tracing.
- ❖ Employees must stay home if feeling ill.
- ❖ Encourage workers who test positive for COVID-19 to disclose to the workplace employer for purposes of cleaning / disinfecting and contact tracing. If the employer is notified of a positive case at the workplace, the employer shall notify the local Board of Health (LBOH) in the city or town where the workplace is located and assist the LBOH as reasonably requested to advise likely contacts to isolate and self-quarantine. Testing of other workers may be recommended consistent with guidance and / or at the request of the LBOH.
- ❖ Employees who are particularly vulnerable to COVID-19 according to the Centers for Disease Control (e.g., due to age or underlying conditions) are encouraged to stay home.
- ❖ Employers must post notice to employees, workers, and customers of important health information and relevant safety measures as outlined in CDC and DPH guidelines.

IV. Cleaning and Disinfecting

- ❖ Employers are required to conduct regular and not less than daily cleaning and sanitation of all high-touch areas such as workstations, door handles, and restrooms. Restrooms should be cleaned and sanitized in accordance with the [EEA COVID-19 Outdoor Recreation Facility Restroom Cleaning Best Practices](#).
- ❖ Launch boats must be disinfected after every trip. Tips should be deposited in a box that can be disinfected prior to retrieval.



- ❖ Pump-out stations should be sanitized after each use. Vessel pump out port areas should be sanitized after the pump out.
- ❖ Boat rental facilities, boat clubs, community-based rowing and sailing facility operators and other operators who offer shared equipment should disinfect all watercraft, shells, safety boats and equipment after each use.
- ❖ Employers should keep cleaning logs that include date, time, and scope of cleaning.
- ❖ Conduct frequent disinfecting of heavy transit areas and high-touch surfaces (e.g., doorknobs, handrails, bathrooms).
- ❖ In event of a positive case, employers must shut down site for a deep cleaning and disinfecting of the workplace in accordance with current guidance.
