CALL MEETING TO ORDER: Acting Chair Watson called the meeting to order at 4:30 pm. Acting Chair Watson read a resignation letter from Bill Dunn effective immediately.

DISCUSSION & POSSIBLE VOTE:

- COVID-19 DISCUSSION with the Board of Health
- O Any concerns, policies, or protocols with regards to the Coronavirus Claire Walsh, Public Health Nurse was present and addressed the Board. She provided an update on statewide number of cases. Groveland has nine (9) confirmed cases. There needs to be more testing. Some people are waiting days for a response to their test. Board of Health received an additional \$2,000 grant to help them deal with this pandemic. Joe is working to ensure that businesses are complying with the guidelines. It was noted that no walking trails have been closed in Groveland.
- Request from the Water/Sewer Superintendent regarding labor staffing
 Colin joined the meeting remotely and requested that staff be limited to the on-call person coming in
 daily and the other two staff members remaining home and coming in as needed. The office and
 equipment are being disinfected on a regular basis.

A motion was moved by Selectman Kastrinelis and seconded by Selectman Wood to accept the recommendation of Water Superintendent Colin Stokes to alter the staff working schedule so that the man on call comes in daily to perform the required work and tend to any time sensitive work that comes up. Voted: 4-0-0.

Employee accrued time

Ms. Dembkoski requested that the Board consider for this year only to change the vacation policy across the board to allow all employees to carry over any unused vacation time provided that it is used by June 30, 2021 with the caveat that if an employee choose to leave or retire before September 30 2020 only ten days of carryover may be bought back and if an employee chooses to leave or retire on or after October 1st would not be eligible to buy back any of the FY20 carryover.

A motion was moved by Selectman Kastrinelis and seconded by Selectman Wood to allow town employees to carry over accrued vacation until June 30, 2021 subject to the following conditions; 1. Anyone that leaves the employment of the town time prior to September 30, 2020 that they will only be paid for ten vacation days and anyone that leaves employment after September 30, 2020 is not eligible for payment of FY20 vacation days and 2: All vacation is subject to approval by the department head. Voted: 4-0-0.

o Discussion of postponing Real Estate Tax Due Date

Ms. Dembkoski explained that per the Governors order the Town can delay the deadline for tax bills and as the Tax Collector she recommended the Board extend the due date for the 4th quarter Real Estate and Personal Property bills to June 1st with interest accruing beginning on June 2nd and outstanding bills will be put on demand before June 30th.

A motion was moved by Selectman Kastrinelis and seconded by Selectman O'Neil to extend the due date for the 4th quarter Real Estate and Personal Property tax bills to June 1st with interest accruing beginning on June 2nd and outstanding bills will be put on demand before June 30th. Voted: 4-0-0.

A motion was moved by Selectman Kastrinelis and seconded by Selectman Wood to proceed forward on the concept to find out if this is cost effective for the Town of Groveland and to ensure that the taxpayers are protected under any agreement that exists between our town and any other town. Voted: 3-1-0.

A motion was moved by Selectman O'Neil and seconded by Selectman Kastrinelis to approve Article 6. Voted: 4-0-0.

Selectman Watson would like to hear from the Board of Assessors regarding Articles 7 and 8.

A motion was moved by Selectman Kastrinelis to approve Articles 7 and 8. There was not a second.

A motion was moved by Selectman Watson and seconded by Selectman Wood to ask for input from the Board of Assessors. Voted: 4-0-0.

Article 41 has to do with the budget, and this is on hold until the meeting on the 27th.

A motion as moved by Selectman Kastrinelis and seconded Selectman Wood to approve Article 42. Voted: 4-0-0.

A motion was moved by Selectman O'Neil and seconded by Selectman Wood to approve Article 43. Voted: 3-0-0.

Selectman Kastrinelis recused herself.
