**CALL MEETING TO ORDER:** Chair Watson opened the meeting and announced it was a late start and that the Town Attorney would not be joining the meeting as anticipated.

**OPEN SESSION:**

Selectman Kastrinelis provided an update to the Trash Contract. There is a communication back from Waste Management. Town Counsel responded to the question regarding whether or not the BOS could consult with other companies regarding trash services and informed the BOS they could not because there is already a signed Memorandum of Understanding; Town Counsel did suggest that if the Town wanted to pursue that further they should first have a discussion with Waste Management. Selectman Kastrinelis read a memo from Town Counsel which addressed changes that are in the amended contract that was returned by Waste Management.

Selectman Kastrinelis stated that Roy from Waste Management responded back that Waste Management had accepted almost all changes, but Roy did not respond to the question regarding how many bags equal a barrel which Selectman Kastrinelis had specifically asked. The Board discussed adding language into the contract to address this. The BOS discussed making additional amendments and submitting the changes to Waste Management. There does not appear to be any substantive changes from Waste Management. If the Town has no further comments a clean copy of the contract will be prepared for the BOS to sign.

A motion was moved by Selectman MacDonald and seconded by Selectman Naves to move for a final draft. Voted: 4-0-0.
