## 6 Merrimack River Road - Information discussion regarding potential garage

<u>Wick</u>: I was originally in front of the Commission regarding this project in 2019, but it got stalled because of COVID and I would like to pick it up again. I would like to put a garage where my existing shed is, maybe about 24x26 feet. The shed would be no closer than 50 feet from the wetland.

Grim: The whole thing would be within the 75 foot no build zone.

Dempsey: Was the shed permitted? That would be good to know before making a decision.

Wick: The shed was there when we moved in 9 years ago. Schindler: I will look through the file and see what I can find.

Bartelt: I think we should do a site visit.

COMMISSION: A site visit at 6 Merrimack River Rd on Saturday June 18th at 9 AM.

#### 38 Benjamin St Ext - Invasive knotweed

Schindler: The developer has been trying to manage this invasive problem. The Planning Board is also concerned about this issue.

<u>Dempsey</u>: The knotweed is not going away, I sent them the UMass Amherst informational sheet, and if they follow that the knotweed wouldn't go away for three years. I would like a professional to weigh in on how to handle this. We should write a letter to the Dehullu's saying we want the invasion evaluated professionally and that they should get back to us in a month.

#### **Veasey Park - Washington Street Parking**

### 55 Main Street - RDA/GRDA Replacement Deck

<u>Schindler</u>: The Commission saw a filing for this property last month for replacement siding that had been rotting. They are back today with plans to replace the deck on the back of the house. <u>Moynihan</u>: That is correct. The replacement deck will be smaller than what is current there. We were hoping to be able to use a mini excavator to take down the old deck, otherwise doing it by hand will take too long.

**COMMISSION**: What is the topography like?

Moynihan: It is almost flat, a slight slope down to the river.

**MOTION**: Dempsey motions to allow for the replacement of the deck at 55 Main Street within the River Front area, with the same constraints as the siding, and no machinery within 100 feet away from the resource area/stream with 50 feet of silt fence at the 100-foot buffer.
