ARTICLE 1: To see if the Town will vote to transfer the sum of EIGHT THOUSAND DOLLARS (\$8,000.00) from Essex Agricultural Assessment line item #01-5-303-650-00 to Municipal Complex Repair line item #01-5-192-228 for the purpose of paying repair bills incurred through June 30, 2000; or take any other action relative thereto.
