**ARTICLE 12:** To see if the Town will vote to approve the \$43,000,000.00 indebtedness authorized by the Regional District School Committee of the Pentucket Regional School District on April 18, 2000, for the purpose of the constructing and equipping of a new grades 9-12 district high school, including the acquisition of land at 90 West Main Street, Merrimac, Massachusetts as a site for the high school, the cost of project management services for plans and specifications for the high school, the cost of project management services to oversee the project and other related costs, which approval shall not take effect until the Town votes to exempt from the limitation on total taxes imposed by G.L. c. 59, §21C (Proposition 2-1/2) amounts required to pay for the Town's share of the principal and interest on the borrowing authorized by the District; or take any other action relative thereto.



Hereof fail not and make due return of this Warrant, with your doings thereon to the Precinct Clerk, at the time and place of said meeting.


