ARTICLE 13: To see if the Town will vote to: (a) authorize the Board of Selectmen to acquire by gift, purchase, or otherwise, upon such terms and conditions as the Selectmen deem appropriate, the fee in a portion of the Webster farm at 44a Wood Street, which portion is more particularly described as Lots 004, 005-A and 007-A on Groveland Assessors Map 8, and approximately 13 acres of the westerly portion of Lot 002 on Assessors Map 5, said lands being part of the lands described in a deed recorded at Book 11308, page 463 with the Southern District of the Essex Registry of Deeds on May 21, 1992, to be managed and controlled by the Conservation Commission in accordance with M.G.L. c. 40, § 8C for conservation purposes; (b) appropriate a sum of money from the Community Preservation Open Space set aside Fiscal Year 2010 funds, and from the Community Preservation General Reserve Fiscal Year 2010 funds, for the purpose of such acquisition which is titled Town Forest Greenway (44a Wood Street), including legal fees and costs related thereto; (c) authorize the Board of Selectmen or their designee to file on behalf of the Town any and all applications deemed necessary under the LAND Program (M.G.L. c. 132A, §11) or any other applications for funds in any way connected with the scope of this acquisition, and to enter into all agreements and execute any and all instruments, including the conveyance of a perpetual conservation restriction in said property meeting the requirements of G.L. c.184, §§31-33, as may be necessary on behalf of the Town to effect said purchase in accordance with Section 12(a) of M.G.L. c. 44B, and all other applicable law, or take any action relative thereto.
